SECOND SUPPLEMENTAL AGREEMENT TO AIRPORT AID AGREEMENT

THIS AGREEMENT AMENDMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and the City of Lee's Summit (hereinafter, "Sponsor").

WITNESSETH:

WHEREAS, the parties entered into an Airport Aid Agreement executed by the Sponsor on November 8, 2017, and executed by the Commission on November 20, 2017 (hereinafter, "Original Agreement") under which the Commission granted the sum of Three Hundred Forty-Six Thousand Three Hundred Thirty-Three Dollars (\$346,333) to the Sponsor to assist in specified Relocate and Extend Taxiway A; Taxiway Lighting and Signage; and

WHEREAS, the parties entered into a First Supplemental Airport Aid Agreement executed by Sponsor on November 22, 2019, and executed by the Commission on December 6, 2019 (hereinafter, "First Supplemental Agreement") under which the Commission granted the Sponsor an additional sum of Three Thousand Five Hundred Sixty-Eight Dollars (\$3,568) and extended the project time period from December 31, 2018 to December 31, 2019, to allow for completion of the work; and

WHEREAS, the parties wish to extend the project time period to allow for completion of the work.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this Agreement, the parties agree as follows:

- (1) <u>PROJECT TIME PERIOD</u>: Based upon the revised project schedule, the project time period of December 31, 2019, will be extended to December 31, 2021, to allow for completion of the work. Paragraph (2) of the First Supplemental Agreement is hereby amended accordingly.
- (2) <u>ORIGINAL AGREEMENT</u>: Except as otherwise modified, amended, or supplemented by this Supplemental Agreement, the Original Agreement and First Supplemental Agreement between the parties shall remain in full force and effect and the unaltered terms of the Original Agreement and First Supplemental Agreement shall extend and apply to this Second Supplemental Agreement.
