**MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION
SECOND SUPPLEMENTAL AGREEMENT TO AIRPORT AID AGREEMENT**

THIS AGREEMENT AMENDMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and the City of Lee's Summit (hereinafter, "Sponsor").

WITNESSETH:

WHEREAS, the parties entered into an Airport Aid Agreement executed by the Sponsor on September 23, 2015, and executed by the Commission on October 5, 2015 (hereinafter, "Original Agreement") under which the Commission granted the sum of Three Hundred Seventy-Eight Thousand One Hundred Seventy-Five Dollars (\$378,175) to the Sponsor to assist in specified Grading for Runway 18/36 Extension and which established a project time period through October 15, 2016; and

WHEREAS, the parties entered into a Supplemental Agreement to the Original Agreement executed by the Sponsor on June 6, 2017, and executed by the Commission on June 13, 2017 (hereinafter, "First Supplemental Agreement") under which the Commission extended the project time period from October 15, 2016 to December 31, 2017, to allow for completion of the work; and

WHEREAS, the parties wish to extend the project time period to allow for completion of the work.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this Agreement, the parties agree as follows:

(1) PROJECT TIME PERIOD: Based upon the revised project schedule, the project time period of December 31, 2017, will be extended to December 30, 2020, to allow for completion of the work. Paragraph (1) of the First Supplemental Agreement is hereby amended accordingly.

(2) ORIGINAL AGREEMENT: Except as otherwise modified, amended, or supplemented by this Supplemental Agreement, the Original Agreement and the First Supplemental Agreement between the parties shall remain in full force and effect and the unaltered terms of the Original Agreement and the First Supplemental Agreement shall extend and apply to this Second Supplemental Agreement.
