## 6. Roundtable

Mr. Brian Head asked the Committee regarding changing the contract term from December 1 to November 30 to December 1 to October 31 each year.

The consensus of the Committee was approval of the change. Mr. Head stated he would check with Mr. Durham of the Britton Group about prorating the first year to accommodate this change. This change would assist the Committee with timing constraints the next time the contract expires.

There was also discussion about a future meeting of the Legislative Intergovernmental Relations Committee and Councilmember Carlyle asked Staff to poll the group for two potential dates: January 4 and 6th, 2021.
