#### **RE:** Input to Human Relations Commission regarding Todd George Road and Boulevard:

According to KCTV5 News, the City of Kansas City MO spent nearly \$60,000 to replace about 189 Paseo street signs. That's about \$355 per sign. Lee's Summit can expect to spend as much if it proceeds with renaming Todd George Parkway. Is this a good use of the taxpayer's money? What does changing street signs accomplish in the way of promoting civil rights, preventing racism, or educating citizens about racism? Moreover, what about the huge inconvenience to people who live on the street? For a fraction of the cost, Lee's Summit could address this issue more effectively and save taxpayer's money.

Here are some courses of action to resolve this issue:

- -Take a portion of the money the city would spend to change street signs and fund civil rights education forums in February 2021, with topics such as:
  - -Public presentation by experts on the resurgence of the Ku Klux Klan, neo-Nazism. other subversive and hate groups.
  - -Public forum...panel discussion on addressing racism in the Lee's Summit community.
  - -Public forum...panel discussion on the legacy and future of civil rights in Jackson County Missouri.
- -Let stand the name of Todd George Parkway considering the totality of Mr. George's life and his overall positive contributions to Lee's Summit.
- -Honor civil rights with a section of U.S. 50 named "Civil Rights (or a specific name) Leader Memorial Highway." The patten for giving a public road a secondary name is "George Brett Super Highway" section of I-70, north of the Truman Sports Complex.
- -Name a new road or street, in a new development of Lee's Summit, for a civil rights leader(s). The leader(s) should be local.
- -Hold a referendum on the issue during the next scheduled municipal election. Let the voters decide, since this is such a divisive issue.

Regarding the aforementioned public forums: The inspiration for public forums comes from the aftermath of apartheid in South Africa. In 1995, public hearings were held where witnesses who were identified as victims of gross human rights violations were invited to give statements about their experiences, and some were selected for public hearings. Perpetrators of violence could also give testimony and request amnesty from both civil and criminal prosecution. This had a powerful positive effect of post-apartheid South Africa and contributed to the current success of race relations in that troubled region. For instance, public polling found South Africa's three main ethnic groups perceived the public hearings as effective. Of course, our contemporary issues, in Lee's Summit, do not compare to the gravity of human rights violations and criminal behavior that took place during apartheid, but the pattern for a public reconciliation of past injustices is established. Public discourse on racial issues is much more effective and less patronizing than merely changing street signs. Additionally, the sponsorship of public civil rights forums puts Lee's Summit in a positive light in advancing the cause of civil rights.

On the other hand, we could end up like the former Yugoslavia. I served two tours as a U.S. Army and NATO peacekeeper in the Balkans (Bosnia-Herzegovina and Kosovo). A central theme of the Yugoslavian Wars of the 1990s was an event that happened in 1389 A.D. in a battle called "Field of the Blackbirds," in an obscure eastern European region called Kosovo. It was conflict between two ethnic groups and, later, was the catalyst for World War I. It also played prominently in re-igniting the current conflict in 1991. Ethnic oriented hate groups are strong in this region, with each splinter group vying to re-write history and cancel (read: kill)

each other. It is textbook fascism. Is this what we want for America—to become "Balkanized" in ethnic enclaves, reminiscent of Sarajevo in Bosnia, or Belfast in Northern Ireland? Do we want to be a divided people, who look to the past to avenge old grudges, rather than looking forward? Renaming a street is probably not going to ignite a war, but failing to directly address the racial divide is not going to diminish the threat.
