AN ORDINANCE APPROVING THE DUAL AWARD OF BID NO. 2021-027, TO PURCHASE SECURITY SYSTEM PRODUCTS AND SERVICES ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO AMERICAN DIGITAL SECURITY LLC AND KENTON BROTHERS LOCKSMITHS, INC. AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued Bid No. 2021-027 ("Bid") for security system products and services; and,

WHEREAS, the Bid was advertised through the City's e-procurement system, Public Purchase, and sent to 88 potential bidders; and,

WHEREAS, at the close of the Bid, five (5) bidders had submitted responsive and responsible bids; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if an existing City contract has or is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council hereby approves the dual award of Bid No. 2021-027 to American Digital Security, LLC and Kenton Brothers Locksmiths Inc. for the purchase security system products and services.

SECTION 2. The agreement between the City and American Digital Security LLC, attached as Exhibit A and incorporated herein by reference, and the agreement between the City and Kenton Brothers Locksmiths Inc., attached as Exhibit B and incorporated herein by reference, are approved, and the City Manager is authorized the execute the same in substantially the same form as the attached by and on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
