The officers, directors, shareholders of QSL Inc. met for the purposes of discussing certain transfers of stock permissible under the provisions of the books and records of the company.

Present was Mei Fen Qiu, Manager of the company as well as Xiang Jiao Lin, who together at the time of the meeting held one hundred percent of the company stock.
