AN ORDINANCE APPROVING AMENDMENT NO. 8 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2021, AS ADOPTED BY ORDINANCE NO. 8905 AND ORDINANCE NO. 8906, BY AMENDING THE AUTHORIZED EXPENDITURES FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, pursuant to Ordinance No. 8905 and Ordinance No. 8906, on June 16, 2020, the City Council adopted the authorized expenditures for the City of Lee's Summit, Missouri, for the Fiscal Year ending June 30, 2021; and,

WHEREAS, capital projects and activities have expenditures approved as part of the annual budget process; and,

WHEREAS, unspent bond issue revenues for transportation work from Orchard Street Bond Fund are no longer needed on a project will be transferred to another active project; and,

WHEREAS, unspent, previously approved expenditures for capital projects and activities from previous fiscal year budgets need to be re-appropriated to the current fiscal year to ensure that spending authority exists to complete the projects and activities; and,

WHEREAS, to use the unspent revenues referenced above in the current fiscal year, the budget needs amended.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2021, of the City of Lee's Summit, Missouri, are amended as set forth in Exhibit A and Exhibit B, each attached and incorporated herein by reference.

SECTION 2. All other provisions of Ordinance No. 8905 and Ordinance No. 8906 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 8937), Amendment No. 2 (Ordinance No. 8941), Amendment No. 3 (Ordinance No. 9007), Amendment No. 4 (Ordinance No. 9045), Amendment No. 4A (Ordinance No. 9046), Amendment No. 5 (Ordinance No. 9023), Amendment No. 6 (Ordinance No. 9024), and Amendment No. 7 (Ordinance No. 9039).

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
