Rodney Wagner, Animal Control Manager, provided a presentation on beekeeping which included research on beekeeping ordinances from other metropolitan cities. Joshua Johnson, Development Services, stated the next step is to collect public feedback, rework the ordinance and bring it back to the Community and Economic Development Committee for review.
