SUMMIT ORCHARDS COMMUNITY IMPROVEMENT DISTRICT

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SUMMIT ORCHARDS COMMUNITY IMPROVEMENT DISTRICT AUTHORIZING SUBMISSION OF SLATE OF SUCCESSOR DIRECTORS.

WHEREAS, pursuant to Ordinance No. 8567 approved on March 6, 2019, the City of Lee's Summit, Missouri (the "City") approved the Petition for the establishment of the Summit Orchards Community Improvement District (the "District") whereby the following initial directors were appointed in accordance with Section 67.1451.6, RSMo:

Conrad Lamb:

four (4) year term

Pat McCambridge:

four (4) year term

Eric Mann:

Casey McCambridge: two (2) year term two (2) year term

Mark Dunning:

two (2) year term

WHEREAS, the initial meeting of the Board of Directors of the District took place on April 16, 2019; and

WHEREAS, the effective dates of the current terms of the initial directors of the District are as follows:

Conrad Lamb:

four (4) year term (April 16, 2019 - April 15, 2023)

Pat McCambridge:

four (4) year term (April 16, 2019 - April 15, 2023)

Casey McCambridge: two (2) year term (April 16, 2019 - April 15, 2021)

Eric Mann:

two (2) year term (April 16, 2019 - April 15, 2021)

Mark Dunning:

two (2) year term (April 16, 2019 - April 15, 2021)

WHEREAS, pursuant to Section F of the Petition, Section 5.6.C of the Cooperative Agreement by and among the City, the District and Townsend Summit, LLC (the "Cooperative Agreement"), and the Bylaws of the District, successor directors shall be appointed by the Mayor with the consent of the City Council by resolution according to a slate submitted by the Executive Director of the District to the City Clerk, which shall serve as a non-binding recommendation for successor director appointments; and

WHEREAS, the Board of Directors of the District desires to authorize the Executive Director to submit a slate of names of suggested successor directors to the City Clerk prior to the expiration of the terms of Casey McCambridge, Eric Mann and Mark Dunning; and

WHEREAS, Casey McCambridge is at least 18 years of age, is legally authorized to represent Townsend Summit, LLC, both an owner of real property and a business operating within the District, and has been a resident of the State of Missouri for at least one (1) year; and

WHEREAS, Eric Mann is at least 18 years of age, is legally authorized to represent Townsend Summit, LLC, both an owner of real property and a business operating within the District, and has been a resident of the State of Missouri for at least one (1) year; and

WHEREAS, Mark Dunning is at least 18 years of age, is legally authorized to represent the City, an owner of real property within the District, and has been a resident of the State of Missouri for at least one (1) year.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SUMMIT ORCHARDS COMMUNITY IMPROVEMENT DISTRICT, AS FOLLOWS:

1. The following slate of names of suggested successor directors (the "Proposed Slate") are hereby approved by the Board of Directors for submission to the City Clerk for appointment by the Mayor with the consent of the City Council:
