AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 28531583 FOR THE BOGGS HOLLOW METER STRUCTURE PROJECT TO INFRASTRUCTURE SOLUTIONS, LLC IN THE AMOUNT OF \$273,280.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, as directed by the FY21 CIP and under authorization of Ordinance No. 8802(A), HDR Engineering, Inc. designed for the installation of a permanent meter structure on the existing Boggs Hollow Interceptor (hereinafter "Project No. 28531583"); and,

WHEREAS, Water Utilities issued an advertisement for bids for the construction of Project No. 28531583 on March 3, 2021, in accordance with local policies and state statutes; and,

WHEREAS, Infrastructure Solutions, LLC (hereinafter "Contractor") was determined to be the lowest and best bidder by City staff; and,

WHEREAS, the City desires to enter into an agreement with the Contractor to construct Project No. 28531583.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby awards the bid for Project No. 28531583 to the Contractor in the amount of \$273,280.00.

SECTION 2. That the agreement between the City of Lee's Summit, Missouri, and the Contractor, attached hereto as "Exhibit A" and incorporated by reference, is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
