## **BILL NO. 21-65**

AN ORDINANCE APPROVING THE DUAL AWARD OF RFP NO. 2021-051, TO PURCHASE UNDERGROUND LOCATING SERVICES ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO USIC LOCATING SERVICES, LLC AND INTEGRITY LOCATING SERVICES, LLC, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued RFP No. 2021-051 ("RFP") for Underground Locating Services; and,

WHEREAS, the RFP was advertised through the City's e-procurement system, Public Purchase, and sent to 97 potential proposers; and,

WHEREAS, at the close of the RFP two (2) proposers had submitted proposals; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if an existing City contract has or is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council hereby approves the City's dual award of RFP No. 2021-051 to USIC Locating Services, LLC and Integrity Locating Services, LLC.

SECTION 2. The City Council approves the agreements between the City and USIC Locating Services, LLC, attached as Exhibit A and the City and Integrity Locating Services, LLC, attached as Exhibit B, and incorporated herein by reference, to purchase underground locating services, and authorizes the City Manager to execute the same in substantially the same form as the attached on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
