AN ORDINANCE APPROVING FOUR INTERGOVERNMENTAL AGREEMENTS BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND THE MISSOURI DEPARTMENT OF TRANSPORTATION TO PROVIDE MOWING AND BEAUTIFICATION SERVICES AS PART OF THE ADOPT-A-HIGHWAY PROGRAM AND AUTHORIZING THE MAYOR TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit (the "City") is a constitutional charter city, organized and existing under the laws of the State of Missouri (the "State"); and,

WHEREAS, the Lee's Summit Beautification Commission (the "Commission") is a City board which exists to coordinate and promote beautification efforts in the City; and,

WHEREAS, over the years the Commission has supported efforts to plant native landscapes along City and State rights-of-way to enhance the visual appeal in the City; and,

WHEREAS, the Commission uses a portion of the funds allocated to it to maintain natural landscapes along certain State rights-of-way; and,

WHEREAS, to continue to maintain the native landscapes planted by the Commission in the State rights-of-way, the State requires the City to enter into an Adopt-A-Highway agreement; and,

WHEREAS, Section 70.220, RSMo., authorizes cooperative agreements between municipalities and other political subdivisions.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The Intergovernmental Agreements between the City of Lee's Summit, Missouri and the Missouri Department of Transportation, through the Missouri Highways and Transportation Commission, for the City's provision of mowing and beautification services along certain Missouri rights-of-way, attached hereto as Exhibit A, Exhibit B, Exhibit C, and Exhibit D and incorporated herein by reference, are hereby approved, and the Mayor is authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
