# 5 COMMUNICATIONS WITH AND REPORTS OF THE COUNTY EXECUTIVE

Dan Tarwater III said he lost a good friend and mentor with the passing of Fred Arbanas.

Frank White Jr., County Executive, made a statement in remembrance and in recognition of the contributions and life of Fred Arbanas, former County Legislator who passed away April 17, 2021. Michele Newman, Director of Parks + Rec, said Fred Arbanas was known to those at the Parks Department as Mr. Parks. Mr. Arbanas gave unending support to expanding the lakes, trails, golf course and other park services. Ms. Newman said the County is placing a commemorative bench at the golf course in recognition of Fred and Sharon Arbanas. She said as soon as it can be arranged everyone is invited to a dedication ceremony to celebrate

this dynamic couple. Tony Miller said that Mr. Arbanas gave a significant contribution to the Little Blue Valley Sewer District, which may be the single most important contribution by Fred to the development of property in Eastern Jackson County. Ronald E. Finley said that Mr. Arbanas was a great example of public service and was always a man of his word. He said, Fred knew what his focus was and committed to accomplishing those goals.

#### 14 NEW BUSINESS

Ronald E. Finley said he was wondering if the County could have information on how often and where our vaccinations are being scheduled. Mr. White said the focus has been on Truman Medical Center and the Jackson County Health Department. Caleb Clifford, Chief of Staff, said the County's website has an updated list of vaccine sites and John Knox Village has a walk-in location for the vaccine.

Dan Tarwater III said he sees an alarming trend with unfilled spots at vaccine events. Mr. Clifford said they are at the point of the vaccine rollout of working on those with vaccine hesitancy. Morning Star Community Development Corporation distributed an update to their vaccine and food distribution program. Jalen Anderson, County Legislator, asked what percentage of County associates have received the vaccine. Troy Schulte, County Administrator, said the vaccine is not required, but he will try to get a report. There is an issue with vaccine hesitancy in the building. He said the County Executive will do more outreach to combat vaccine hesitancy. Mr. Anderson asked why associates are hesitant. Mr. Schulte said they have heard a variety of issues about safety and convenience. They will continue to provide more opportunities for shots onsite. Theresa Cass Galvin reminded everyone due

to HIPAA issues the County cannot ask who is vaccinated. They are not mandating the vaccine because of the additional problems it presents. Crystal Williams, County Legislator, asked about mandating that associates come back to work, but not mandating the vaccine. Caleb Clifford said that mandating the vaccine creates complex legal issues. They are strongly encouraging associates to get the vaccine. The mask mandate is continuing. Some associates are working remotely on a case-by-case basis. Bryan Covinsky, County Counselor, said they are doing what they can to encourage associates to get the vaccine. Jalen Anderson asked if there are other requirements for associates to work at the County. Caleb Clifford said the County encourages flu shots through the health care plan, but there is no requirement on other vaccines.

## Discussion.

Frank White, Jr., said many of these concerns will be discussed at the Department Managers Meeting scheduled for April 20, 2021.

Jalen Anderson expressed his concerns about the numerous shootings across the United States recently. He hopes we can find a solution to this violence and to fight the epidemic of COVID and violence.

Dan Tarwater III asked about the timeline for associates to come back to work. Troy Schulte said this is being handled on a case-by-case basis. The County has had a generous leave policy during COVID to encourage associates to get tested and quarantine. It may be that to continue these policies, associates may need to show they have been vaccinated. It may also be necessary to implement work from home schedules if there is a delay in repairs to the County's climate control system.

## 15 ADJOURNMENT

A motion was made by Theresa Cass Galvin, seconded by Tony Miller, to adjourn the meeting. The motion passed by a voice vote.
