AN ORDINANCE AUTHORIZING THE EXECUTION OF A GOVERNOR'S TRANSPORTATION COST SHARE AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION RELATED TO THE PUBLIC IMPROVEMENT PROJECT DESIGNATED AS FEDERAL PROJECT NUMBER STP-3301(527), COLBERN ROAD, WITHIN THE CITY LIMITS OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Pursuant to the FY2019 Capital Improvement Plan and Thoroughfare Master Plan, the City planned for improvements along Colbern Road between MO-350 Hwy and Douglas Road to enhance safety, expand capacity, promote economic development in the area, and accommodate non-motorized transportation (hereinafter "Project").and.

WHEREAS, The Missouri Highways and Transportation Commission ("hereinafter MoDOT") approved the City's submittal of the Project for Surface Transportation Program federal funding in the amount of \$3,975,000 (hereinafter "Federal Project Number STP-3301(527)"); and

WHEREAS, MoDOT also approved the City's application to the Governor's Transportation Cost Share Program and allocated \$8,000,000 for the construction of Federal Project Number STP-3301(527).; and,

WHEREAS, An agreement between the City and MoDOT is necessary to memorialize the mutual covenants, promises, and representations for Federal Project Number STP-3301(527) for the Cost Share Program and Surface Transportation Program (hereinafter "Governor's Cost Share Agreement").

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

- SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby approves the Governor's Cost Share Agreement as attached hereto as "Exhibit 1".
- SECTION 2. That the Mayor is hereby authorized to execute the same by and on behalf of the City of Lee's Summit, Missouri.
- SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
