## **BILL NO. 21-114**

AN ORDINANCE APPROVING THE USE OF A COOPERATIVE CONTRACT BETWEEN THE JASPER COUNTY SHERIFF'S OFFICE AND TURN-KEY MOBILE, INC., TO PURCHASE COMPUTER AND NETWORK TECHNOLOGY AS NEEDED AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City") has a need to purchase computers and network technology for Police vehicles; and,

WHEREAS, Section 6.1 of the Procurement policy allows the City to make purchases from contracts that were originally procured by another entity but have extended the pricing and terms of such contract to other entities such as the City; and,

WHEREAS, the City is able to utilize computers and network technology equipment pursuant to a contract between the Jasper County Sheriff's Office and Turn-Key Mobile, Inc.; and,

WHEREAS, Section 4 of the Procurement Policy requires a cooperative contract with an estimated annual spend of \$50,000.00 or more to be approved by City Council before it is used; and,

WHEREAS, the City anticipates spending over \$50,000.00 annually on the purchase of computers and network technology.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's use of the Jasper County Sheriff's Office computer and network technology contract with Turn-Key Mobile, Inc. (referred to as "Cooperative Agreement"), attached as Exhibit A and incorporated herein by reference, and authorizes the City Manager execute all documents necessary to use the Cooperative Agreement to purchase computer and network technology.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
