The estimated cost to fund the route that would go to 3-Trails Transit Center in 2019 was between \$96,250 and \$131,250 a year. The Community Bus Service - ATA/OATS program would only need an increase between \$150,000 and \$200,000 a year to fund this new fixed transit route projects. The city spends a lot more money per year on the Annual Curb and Gutter Replacement program and the Overlay & Slurry Seal program than the Community Bus Service - ATA/OATS program. A transit funding approach may be to reduce both the Annual Curb and Gutter Replacement program and the Overlay & Slurry Seal program by \$150K-\$200K in support of transit and the reduction to Curb and Overlay funding would be proportionate to current funding allocations. The drop in pavement/curb level of service would not be very noticeable considering such a minor amount of funds (\$150K-\$200K) redirected from the \$6M+ combined annual programs. It is not equitable that transit is significantly underfunded compared to other programs. There needs to be more funding sources so that the city can fund more transit and road improvements (maintenance) at the same time. However, until there is another funding source, it is worth taking a small percentage of money from a highly funded program and moving it to transit. Removing \$150,000 each from the Annual Curb and the Gutter Replacement program and the Overlay & Slurry Seal program would be removing around 5% of the total \$6M+ combined annual programs.
