PUBLIC SERVICE AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT AND DOWNTOWN LEE'S SUMMIT MAIN STREET, INC.

THIS Public Service Agreement ("Agreement") is entered into by and between the City of Lee's Summit, Missouri ("City"), a Missouri municipal corporation, and Downtown Lee's Summit Main Street, Inc. ("Main Street"). The City and Main Street may be referred to individually as the "Party" and collectively as the "Parties."

RECITALS

WHEREAS, in 1989, a group of business and civic leaders came together to revitalize downtown Lee's Summit in which there were over 19 vacant buildings and declining investment due to the growth of sprawl and new auto-dependent shopping centers on the edges of the community nearer the highways and interstate; and

WHEREAS, the business community, in partnership with the City, incorporated the not-for-profit, Downtown Lee's Summit Main Street, Inc., obtained its Section 501(c)(3) educational and charitable designation, and engaged to implement the national Main Street Four-Point Approach to economic revitalization; and

WHEREAS, over the ensuing 32 years, the Downtown Lee's Summit Main Street organization has led the successful revitalization of Downtown Lee's Summit and continues to challenge itself and the community with the continued use of the Main Street Four-Point Approach to economic revitalization of (i) Organization (encouraging cooperation, recruiting members and building leadership in the business community); (ii) Promotion (creating a positive image for downtown and promoting it as a viable place to live, shop and invest); (iii) Economic Vitality (developing business retention, expansion and recruitment strategies); and (iv) Design (providing design education and assistance to improve the appearance of downtown and promote and foster historic preservation); and

WHEREAS, as a result of the decades of partnership, the national leaders at the Main Street Center and the American Planning Association have recognized and awarded the work in 2010 with the National Main Street Center prestigious Great American Main Street award, and the American Planning Association named Downtown Lee's Summit a 2019 Great Neighborhood; and

WHEREAS, the Mayor and City Council have determined that it is in the best interests of the Lee's Summit community, and important to the promotion of the general economic welfare of Downtown Lee's Summit, to continue to financially support the work of Main Street in its continued focus with the Main Street Four-Point Approach.

NOW, THEREFORE, the Parties, in consideration of the above recitals and the following mutual covenants and stipulations, agree as follows:

I. Main Street Scope of Services

Main Street shall:

- A. Perform the following scope of services for the City:
 - 1. *Organization*: Main Street shall provide unified management and coordination for the Downtown Core Area, as depicted in Exhibit A, attached and incorporated herein, through Main Street's interaction with its investors, volunteers, the City, businesses and property owners in the Downtown Core Area, and community partners to continue to contribute toward the economic revitalization of the Downtown Core Area.
 - 2. *Promotion*: Main Street shall continue to develop, and regularly review and update a consistent marketing and promotion program for the Downtown Core Area. The marketing and promotion program shall include producing quality marketing pieces, coordinating advertisements, and organizing annual events/activities that attract visitors to the Downtown Core Area. Whenever possible, the marketing and promotion program should be coordinated with the other community marketing partners to support the "Yours Truly" community brand.
 - 3. Economic Vitality: Main Street shall continue to strengthen the existing economic assets of the Downtown Core Area while diversifying its economic base, including recruiting new businesses, assisting with expansion of existing businesses, facilitating redevelopment, marketing available or underutilized commercial space, and strengthening the management capabilities and competitiveness of individual businesses. Main Street shall track key statistics, including job growth and new businesses in the Downtown Core Area, and host business development seminars based on the needs of the downtown business community. Main Street serves as the key point of contact for interested parties looking to invest in the Downtown Core Area.
 - 4. *Design*. Main Street shall continue to initiate and develop design proposals for the continued evolution of the overall aesthetic look of the Downtown Core Area. Main Street will assist City staff with the implementation and education of the City's Design Standards for the Downtown Core Area.
- B. Only use the Funds, as defined below, for the performance of the services set forth in Subsection A of this Section. Any use of the Funds for a purpose other than authorized in this Agreement shall be a material breach of this Agreement, and Main Street shall return any unspent Funds and an amount equal to the amount used for an unauthorized purpose.
- C. Maintain accurate records of all monies received from the City and the use and disbursal of all such monies. Main Street shall maintain an accounting system which complies with generally accepted accounting principles, and with the American Institute of Certified Public Accountants Audit Guide for Non-Profit Corporations and shall separately account for the Funds provided by the City pursuant to this Agreement.
- D. On or before July 1st of each year this Agreement is in effect, provide the City with its approved budget for the upcoming fiscal year, the names of the officers or directors of Main Street.

- E. At execution of this Agreement, provide the City a copy of the current Main Street bylaws, articles of incorporation and any amendments thereto. In the event of any change of officer and/or director, bylaws, or amendments to the articles of incorporation, during the term of this Agreement, Main Street shall provide the City a copy of the updated documents and/or information.
- F. Each year this Agreement is in effect, Main Street shall submit biannual program status reports documenting activities from July 1st to December 31st ("First Report") and January 1st to June 30th ("Second Report"). The reports shall document the revenue and disbursements of monies received from the City, and shall contain analytical memoranda which:
 - 1. Describes results of activities and expected achievements; and
 - 2. Describes program effectiveness; and
 - 3. Lists capital expenditures, if applicable.

The First Report shall be submitted to the City on or before January 15th each year this Agreement in effect. The Second Report shall be submitted to the City on or before July 15th each year this Agreement in effect.

Main Street shall also provide a semi-annual in-person presentation to the City Council. The dates of such in-person presentations shall be determined by the City Council.

The Vice Chair and Secretary of Main Street shall participate on the Community Partner Board, which shall be comprised of representatives from the City and members of the board of directors from Lee's Summit Economic Development Council, Downtown Lee's Summit Main Street, Inc., the Lee's Summit Chamber of Commerce, and Velocity Lee's Summit, Inc. The Community Partner Board shall meet at least semi-annually. Community Partner Board meetings shall be scheduled by the City.

The City Manager may also require Main Street to periodically provide a brief statement or status report City regarding the services under this Agreement in a form most amenable to the subject matter of the report.

II. FINANCIAL SUPPORT AND TERM OF AGREEMENT

- A. The initial term of this Agreement shall be for one year commencing on July 1, 2021, and ending on June 30, 2022 ("Initial Term"). Upon expiration of the Initial Term, this Agreement shall automatically renew for up to two, one-year periods unless notification is given of intent to not renew by either party in writing, no less than thirty (30) days, prior to the date of automatic renewal, and subject to annual appropriation by the City Council as contemplated herein, or otherwise terminated by the City as set forth herein.
- B. The City agrees to pay to Main Street an amount up to \$60,000.00 ("Funds") each fiscal year of the City this Agreement is in effect. During the Initial Term and any renewal terms, the City shall distribute the Funds in twelve (12) equal monthly installments on or before

the 15th day of each month, starting in July 2021. Notwithstanding anything to the contrary in this Agreement, the Funds are subject to the annual appropriation by the City Council and if the Funds are not appropriated or only partially appropriated, Main Street agrees the City shall be not be required or liable to provide the unappropriated amount. Notwithstanding anything to the contrary in this Agreement, all monthly installments are subject to the availability of such funds in the City's Business and Industry Fund. If the City's Business and Industry Fund does not have adequate revenues to fulfill all of its obligations, as determined solely by the City, the City is not obligated to distribute the monthly installment to Main Street for that month or any future monthly installments until sufficient funds are available. Main Street understands and agrees that the City has no duty to retroactively pay a monthly installment that was not distributed on the first of the month due to insufficient funds.

- C. Nothing in this Agreement shall preclude the City from contracting separately with Main Street for services upon terms and conditions agreed to by the City and Main Street.
- D. In no event shall Main Street use any monies received from the City under this Agreement to increase the compensation of any Main Street employee or officer. "Compensation" as used herein includes salary, commissions, bonuses or other monies, but does not include reimbursements for expenses, such as travel, materials or supplies if expenses are incurred in the course of furthering the objectives of this Agreement.

III. TERMINATION

- A. This Agreement may be terminated by the City at any time by written, mutual agreement of the parties. The City may terminate the Agreement immediately if funds are not appropriated for the Services described herein. The City shall have the right to terminate this Agreement in the event that Main Street is in default or violation of the terms or provisions of this Agreement and fails to cure such default or violation in the manner specified in Subsection B below.
- B. In the event of a default or violation by Main Street, the City shall send to Main Street by certified mail a notice demand to cure default, explaining the specific nature and extent of the default of violation. Main Street shall cure or remedy said violation or default within twenty (20) working days after receipt of said Notice, unless a longer time is agreed upon by both parties in writing. In case the default is not cured or remedied within twenty (20) working days or a longer period of time if agreed upon, the City may exercise its option to terminate this Agreement upon five (5) days written notice thereafter. Main Street shall not be relieved of liability to the City for damages sustained by the City by virtue of any breach of this Agreement by Main Street.
- C. In the event of termination, Main Street shall refund to the City a pro-rated portion of the compensation paid pursuant to Section II above. The pro-rated amount shall be determined by dividing the monthly payment recited in Section II by 30 ("Daily Amount"), and multiplying the Daily Amount by the number of days remaining in the month from and

after the effective date of termination. Main Street shall refund the pro-rated amount to the City within 30 days of the effective date of termination.

IV. INDEMNIFICATION

To the fullest extent permitted by law, Main Street shall defend, indemnify and hold harmless the City, and the City's council member, officer, director, employee or agent thereof (the City and any such person being herein called an "Indemnified Party") for, from, and against all claims, liabilities, demands, damages, losses, fines, penalties, injuries to property or persons (including death), and expenses (including attorney fees and litigation expenses, and the cost of appellate proceedings) (collectively "Claims") to the extent that such Claims relate to, result from and/or arise out of Main Street's acts, errors, directives, or omissions, in performance of this Agreement. The obligations of this Section include the acts, errors, mistakes, directives, or omissions of Main Street's employees, agents, advertisers, contractors, subcontractors, or any other person for which Main Street may be legally liable, in the performance of this Agreement, provided that this obligation shall not apply to the City's negligence in the performance of this Agreement.

The amount and type of insurance coverage requirements set forth in this Agreement will in no way be construed as limiting the scope of the indemnity in this Section. The indemnity requirements set forth in this Agreement will in no way be construed as limiting the insurance required in this Agreement or waiving the City's sovereign immunity.

V. INSURANCE

A. General.

- 1. *Insurer Qualifications*. Without limiting any obligations or liabilities of Contractor, Contractor shall purchase and maintain, at its own expense, hereinafter stipulated minimum insurance with insurance companies authorized to do business in the State of Missouri, with an AM Best, Inc. rating of A- or above with policies and forms satisfactory to the City. Failure to maintain insurance as specified herein may result in termination of this Agreement at the City's option.
- 2. No Representation of Coverage Adequacy. The City shall have the right to review any and all of the insurance policies and/or endorsements cited in this Agreement, but has no obligation to do so. Failure to demand such evidence of full compliance with the insurance requirements set forth in this Agreement or failure to identify any insurance deficiency shall not relieve Main Street from, nor be construed or deemed a waiver of, its obligation to maintain the required insurance at all times during the performance of this Agreement.
- 3. Coverage Term. All required insurance shall be maintained in full force and effect until all work or services required to be performed under the terms of this Agreement are satisfactorily performed, completed and formally accepted by the City, unless specified otherwise in this Agreement.

- 4. *Primary Insurance*. Main Street's insurance shall be, or endorsed to be, primary, non-contributory insurance with respect to performance of this Agreement and in the protection of the City as an Additional Insured.
- 5. *Claims Made*. The parties agree that no policies required under this Section shall be made in a claims made basis.
- 6. Policy Deductibles and/or Self-Insured Retentions. The policies set forth in these requirements may provide coverage that contains deductibles or self-insured retention amounts. Such deductibles or self-insured retention shall not be applicable with respect to the policy limits provided to the City. Main Street shall be solely responsible for any such deductible or self-insured retention amount.
- 7. Use of Subcontractors. If any of the services under this Agreement is subcontracted in any way, Main Street shall execute written agreements with its subcontractors containing the indemnification provisions set forth in this Section and insurance requirements set forth herein protecting the City and Main Street. Main Street shall be responsible for executing any agreements with its subcontractors and obtaining certificates of insurance verifying the insurance requirements.
- Evidence of Insurance. Prior to receiving any Funds, or commencing any work or 8. services under this Agreement, Main Street will provide the City with suitable evidence of insurance in the form of certificates of insurance, endorsements, and a copy of the declaration page(s) of the insurance policies as required by this Agreement, issued by Main Street's insurance insurer(s) as evidence that policies are placed with acceptable insurers as specified herein and provide the required coverages, conditions and limits of coverage specified in this Agreement and that such coverage and provisions are in full force and effect. The City may reasonably rely upon the certificates of insurance, endorsements, and declaration page(s) of the insurance policies as evidence of coverage but such acceptance and reliance shall not waive or alter in any way the insurance requirements or obligations of this Agreement. If any of the policies required by this Agreement expire during the life of this Agreement, Main Street shall forward renewal certificates and declaration page(s) to the City thirty (30) days prior to the expiration date. All certificates of insurance and declarations required by this Agreement shall be identified by referencing the title or this Agreement. Certificates of insurance and declaration page(s) shall specifically include the following provisions:
 - a. The City, its agents, representatives, officers, directors, officials and employees are Additional Insureds for commercial general liability under Insurance Services Office, Inc., ("ISO") Form CG 20 10 03 97 or equivalent.
 - b. Main Street's insurance shall be primary, non-contributory insurance with respect to performance of the Agreement.
 - c. All policies, except for Professional Liability, including Workers' Compensation, waive rights of recovery (subrogation) against City, its agents, representatives, officers, officials and employees for any claims arising out of work or services performed by Main Street under this Agreement.

All Certificates of Insurance shall name the City of Lee's Summit as the certificate holder and send the certificate and any endorsements to:

- 9. *Endorsements*. Main Street shall provide the City with the necessary endorsements to ensure City is provided the insurance coverage set forth in this Section.
- B. Required Insurance Coverage. Main Street shall maintain "occurrence" form Commercial General Liability insurance with an unimpaired limit of not less than \$1,000,000 for each occurrence, \$2,000,000 Products and Completed Operations Annual Aggregate and a \$2,000,000 General Aggregate Limit. The policy shall cover liability arising from premises, operations, independent contractors, products-completed operations, bodily injury, personal injury and advertising injury. Coverage under the policy will be at least as broad as ISO policy form CG 00 01 93 or equivalent thereof, including but not limited to, separation of insured's clause. To the fullest extent allowed by law, for claims arising out of the performance of this Agreement, the City, its agents, representatives, officers, officials and employees shall be endorsed as an Additional Insured under ISO, Commercial General Liability Additional Insured Endorsement form CG 20 10 03 97, or equivalent. The policy shall contain an endorsement waiving rights of recovery (subrogation) against the City, its agents, representatives, officials, officers and employees. If any Excess insurance is utilized to fulfill the requirements of this subsection, such Excess insurance shall be "follow form" equal or broader in coverage scope than underlying insurance.
- C. <u>Cancellation and Expiration Notice</u>. Insurance required herein shall not expire, be canceled, or be materially changed without thirty (30) days' prior written notice to the City.
- D. <u>Workers Compensation</u>: Main Street understands and agrees that Main Street's employees, agents, contractors, volunteers, and directors, are not serving as an employee of the City in any manner and therefore are not entitled to any of the City's industrial benefit coverages, including Workers' Compensation coverages. Main Street acknowledges that any injury its employees sustain in the performance of this Agreement will be not be eligible for industrial benefits through the City and any necessary treatment will be Main Street, or Main Street's insurer's, sole responsibility.

VI. GENERAL CONDITIONS

A. <u>Non-Discrimination Laws</u>. Main Street shall not discriminate against any person on the basis of race, religion, color, age, sex, disability, or national origin in the performance of this Agreement, and shall comply with the terms and intent of Title VII of the Civil Rights Act of 1964, as amended, the Rehabilitation Act of 1973, as amended, which prohibits discrimination in the employment or advancement in employment of qualified persons

because of physical or mental disability, and with the Americans with Disability Act of 1990. In addition, Main Street shall include similar requirements of subcontractors in any written contracts entered into for performance of Main Street's obligations under this Agreement.

- B. <u>Financial Review</u>. Main Street shall make all of its financial records related to the Funds available for inspection by the City, or its designee, upon reasonable notice during normal business hours of the City. If the City desires a financial audit by an independent certified public accountant of the Main Street's financial records to verify use of the Funds according to the terms and conditions of this Agreement, Main Street shall cooperate fully in the performance of such audit. If the audit reveals that Main Street misappropriated the Funds received from the City, the City may require Main Street to cover the cost of such an audit. Main Street is entitled to a copy of any resulting reports that are received by the City.
- C. <u>Compliance with Laws</u>. Main Street shall comply with all federal, state, and local laws and ordinances applicable to its performance under this Agreement. In addition, Main Street shall include similar requirements of its contractors in any written contracts entered into for performance of Main Street obligations under this Agreement.
- D. <u>Successors and Assigns</u>. This Agreement is not assignable unless both Parties mutually consent otherwise in writing and signed by both Parties. The requirements of this Agreement are binding upon the successors, and assigns of both Parties.
- E. <u>Attorney Fees and Costs</u>. In the event any action, suit or proceeding is brought for failure to observe any of the terms, covenants, or provisions of this Agreement, the prevailing party shall be entitled to recover as part of such action or proceeding, all litigation, arbitration and collection expenses, including, but not limited to, witness fees, court costs, and reasonable attorney fees.
- F. <u>Laws Governing/Venue</u>. This Agreement shall be governed by the laws of the State of Missouri, as to validity, interpretation and performance. Any and all suits for any and every breach of this Agreement, or other judicial proceeding for the enforcement or interpretation of this Agreement shall be instituted and maintained in State Court in eastern Jackson County, Missouri.
- G. <u>Non-Waiver</u>. The failure or delay of either Party to insist upon strict performance of any of the provisions of this Agreement, or to exercise any of the rights or remedies provided by this Agreement, shall not release either Party from any of the responsibilities or obligations imposed by law or by this Agreement, and shall not be deemed a waiver of any right of either Party to insist upon strict performance of this Agreement.
- H. <u>Severability</u>. If any part, term or provision of this Agreement is by the courts held to be illegal or in conflict with any law of the State of Missouri, the validity of the remaining portions or provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the Agreement did not contain the particular part, term, or provision held to be invalid.

- I. <u>Entire Agreement and Amendments</u>. This instrument contains the entire Agreement between the Parties, and no oral or written statement, promises, or inducements made by either Party or agent of either Party that is not contained in this written Agreement, or specifically referred to in this written Agreement shall be valid or binding; and this Agreement may not be enlarged, modified, or altered except in writing signed by both Parties.
- J. <u>Relationship of Parties</u>. The Parties understand and expressly agree that Main Street is an independent contractor and is not an employee of the City. Nothing in this Agreement constitutes a partnership or joint venture between the Parties and neither Party is the principal or agent of the other.
- K. <u>Rights/Obligations of Parties Only</u>. The terms of this Agreement are intended only to define the respective rights and obligations of the Parties. Nothing in this Agreement shall create any rights or duties in favor of any potential third-party beneficiary or other person, agency or organization.
- L. <u>Time of the Essence</u>. Time is of the essence in this Agreement. Unless otherwise specifically provided in this Agreement, any consent to delay in the performance of Main Street of any obligation shall be applicable only to the particular transaction to which it relates, and it shall not be applicable to any other obligation or transaction.
- M. Work Authorization/E-verify. Pursuant § 285.530, RSMo., if Agreement exceeds five thousand dollars (\$5,000.00), Main Street warrants and affirms to the City that (i) Main Street is enrolled and participates in a federal work authorization program with respect to the employees working in connection with the contracted services and (ii) Main Street does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.

Main Street shall swear to and sign an affidavit declaring such affirmation, and provide the City with supporting documentation of its enrollment and participation in a federal work authorization program with respect to the employees working in connection with this Agreement. Attached hereto and incorporated herein as Exhibit B, the Main Street E-Verify Affidavit.

- N. <u>Political Activities</u>. Main Street shall not use the compensation paid through this Agreement for political activities or legislative activities. For the purpose of this Agreement, the terms "political activities" and "legislative activities" shall have the meanings ascribed to them by the Internal Revenue Service.
- O. <u>Anti-Discrimination Against Israel Act</u>. Pursuant to Section 34.600, RSMo and to the fullest extent permitted by law, if this Agreement has a total potential value of \$100,000 or more and Main Street has 10 or more employees, Main Street certifies that Main Street is not engaged in a boycott of Israel as of the Effective Date of this Agreement, and agrees for the duration of this Agreement to not engage in a boycott of Israel as defined in Section 34.600, RSMo.

P. <u>Notices</u>. Unless otherwise provided in this Agreement, all notices, demands, requests, consents, approvals and other communications (collectively "Notices") required or permitted hereunder shall be in writing and delivered by registered or certified U.S. mail, postage prepaid, or personally delivered, at the address shown below. Notices shall be deemed received at the time of actual receipt, which shall be evidenced by a copy of receipt (in the case of notices that are personally delivered), or as evidenced by the United States Postal Service receipt; or five (5) calendar days after mailing, whichever comes first, in the case of notices that are mailed.:

- Q. <u>Provisions Required by Law</u>. Each and every provision of law and any clause required by law to be in this Agreement will be read and enforced as though it were included herein and, if through mistake or otherwise any such provision is not inserted, or is not correctly inserted, then upon the application of either Party, this Agreement will promptly be physically amended to make such insertion or correction.
- R. <u>E-Signature and Counterparts</u>. The Parties agree that this Agreement may be signed in two or more counterparts and/or signed electronically, and all such counterparts together shall constitute one and the same contract; such signatures shall bind the signing party in the same manner as if a handwritten signature had been delivered.
