ARPA

- Established the Coronavirus State and Local Fiscal Recovery Funds
- Appropriated \$130.2 Billion
- Distribution based on HUD Formulas —Lee's Summit was appropriated \$8,310,882



ARPA

- Funding is available in 2 "tranches"
- \$4,155,441 has been received
- Tranche 2 will be received no earlier than May 2022



Use of Funds

- Federal Intent is to mitigate the fiscal effect stemming from COVID-19
 - Mitigation and response to COVID-19
 - Negative economic impacts of COVID-19
 - Provide premium pay to "eligible workers" of the City that are performing "essential work" or providing "grants to eligible employers" that have such workers
 - Recoup revenue losses "due to COVID-19"
 - Necessary investments in water, sewer, or broadband infrastructure
- Costs must be incurred between March 3, 2021 and December 31, 2024



ARPA vs CARES Act

ARPA

- Directly awarded to Lee's Summit
- Encumbered by 12/31/2024
- Broad eligible uses
- Focus on external recovery

CARES Act

- Awarded through Jackson County
- Spent by 12/31/2021
- Narrow eligible uses
- Focus on internal recovery

- Support a healthy, happy community by improving healthy lifestyle choices and opportunities

- Enhance current educational opportunities and plan for future educational opportunities that support the City's economic development

- Create and maintain a variety of housing options, styles and price ranges

• Build an adaptable framework for continued growth in a changing environment

Multimodal Transportation

- Safe, convenient and accessible travel options in the parts of the City where a more balanced system is key to a high quality of life
- Enhance existing approaches in the rest of the City outside of Activity Centers and Connecting Corridors
- Provide a transportation network for any mode or technology that will be connected, complete, resilient and adaptable to the future

Facilities & Infrastructure

- Sustain and enhance City services and facilities to protect a high quality of life
- Plan and build City services and infrastructure to promote quality growth and resiliency
- Increase disaster resiliency

Community Engagement

• Create a healthy and balanced community for all voices

- Conformance with ARPA Requirements
- Strong and equitable recovery
- Amount of community impact
- Connection to identified Community Needs
 - Ignite Strategic Plan
 - Ignite Comprehensive Plan
 - Consolidated Plan
- Consideration of additional funding sources
- One-time funding needs vs on-going expenditures

Budget Recommendation

Total	\$ 8,310,882.00

- COVID Reserve to be adjusted based upon actual conditions
- Lost Revenue to be calculated at the end of each Calendar Year
- Strategic Objectives to be prioritized based upon project selection framework
