

**BILL NO. 21-176**

AN ORDINANCE APPROVING THE USE OF A COOPERATIVE CONTRACT BETWEEN THE CITY OF KANSAS CITY, MISSOURI, AND JCI INDUSTRIES, LLC, TO PURCHASE WATER PUMP SUPPLIES, EQUIPMENT, AND REPAIR SERVICES AS NEEDED AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME.

WHEREAS, the City of Lee's Summit, Missouri (the "City") has a need to purchase water pump supplies, equipment, and repair services for use by Water Utilities Department; and,

WHEREAS, Section 6.1 of the Procurement policy allows the City to make purchases from contracts that were originally procured by another entity but have extended the pricing and terms of such contract to other entities such as the City; and,

WHEREAS, the City is able to purchase water pump supplies, equipment, and repair services pursuant to a contract between the City of Kansas City, MO and JCI Industries, LLC; and,

WHEREAS, the City anticipates spending over \$50,000.00 annually on the purchase of water pump supplies, equipment, and repair services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council approves the City's use of the City of Kansas City, Missouri water pump supplies, equipment, and repair service contract with JCI Industries, LLC (referred to as "Cooperative Agreement"), attached as Exhibit A and incorporated herein by reference, and authorizes the City Manager to execute all documents necessary to use the Cooperative Agreement to purchase water pump supplies, equipment, and repair services from JCI Industries, LLC.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
