#### 11. Council Comments:

Councilmember Forte said she has had several citizens reach out to her that are not in favor the mask mandate and want to know why Lee's Summit is still under the regulation of Jackson County. She said she worries this will cause many citizens to go to Independence or Cass County that do not have to follow the mask mandate and did not implement one themselves. She stated she is also worried about the loss to businesses because of this mandate would like Council to discuss the City having their own health department.

Councilmember Edson also asked how the City can get their own health department so we are no longer under the jurisdiction of the Council.

Councilmember Edson also noted the Public Works Committee was held last week and Mr. Mike Anderson and Mr. Shawn Graff introduced several members of the Public Works Department team that the Committee and Council do not see on a normal basis. She thoroughly enjoyed being introduced to them.

Councilmember DeMoro agreed with both Councilmember Forte and Edson and said he feels it is time for the City to control our own destiny and not be forced to follow the guidelines of the County.

Councilmember Shields said she has heard from several citizens that are in favor of the mask mandate and that it makes them feel safer for their kids as well. She also stated she would like to have Closed Sessions in person and feels they are more productive.

Councilmember Felker agreed the City should start the health department conversation as we move forward. He would also like to have Closed Sessions in person.

Councilmember Felker asked when the Council would start discussing the census and timeline on redistricting. Mayor Baird asked staff to provide an update during Staff Roundtable.

Councilmember Johnson stated he is not opposed to the idea of having a health department for the City but he want to know what the cost would be and recognize the cost would be an annual cost and not a one time cost.

Mayor Baird agreed to having more in person Closed Sessions but wanted Council to realize that means later nights at Council meetings or more nights having meetings in person. He stated he still feels Zoom is a very viable option and will continue using that platform as well.

Mayor Baird also stated that staff is working on requirements, costs and needs of having a health department. He does not want occupancy restrictions implemented again but prefers to look into options to not go against state regulations or give anyone cause for legal ramifications.

#### 12. Staff Roundtable

Assistant Fire Chief Dan Manley provided an update on COVID and the current issues with the Delta variant.

Police Chief Travis Forbes provided a brief update on the remodeling of the Police and Municipal Court building. He said the new look is very different and he feels it's a very impressive and positive change. Many departments have already moved back in. Police Operations will be moving back in by the end of the month and Municipal Courts will be moving back in soon after Operations.

Mr. Ryan Elam, Director of Development Services, stated the Census information was received last week. They are currently working on getting the GIS connections and mapping done. He said this should be complete by the end of next week and then he can provide a better estimate of dates and times for the redistricting process to Council.
