- B. [2021-3974](#)** Discussion of pending State Legislative Items

City Attorney Brian Head went over the most recent report from Jim Durham, the City's lobbyist. The discussion centered primarily around HB554 and SB153 which modify provisions relating to taxation and how they would effect local governments.

Brian mentioned that if HB554 passes - we would be required to participate in the Sales Tax Holiday and it would lower franchise fees. If SB153 passes - it would expand the Use Tax of online sales to those entities that aren't subject to participate currently (i.e. small internet retail).

Councilmember Shields left the meeting at 11:50 a.m.

Staff asked the Chair if she would like him to contact the lobbyist to find out where we stand on HB153 and SB554 and if Senator Koenig doesn't offer the amendment or it is not successful on the second vote, that we express our opposition on the grounds that it will actually be harmful to revenue with the other two reductions.

Consensus was to have Staff contact Mr. Durham and explain our position.

## **6. Roundtable**

Since the Committee assignments will be changing at the first Council meeting in June, it was decided not to set a next meeting of the Committee until after that happens.
