

BILL NO. 21-200

AN ORDINANCE APPROVING AMENDMENT NO. 3 TO THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) 2020-21 ANNUAL ACTION PLAN.

WHEREAS, in August of 1994, the City of Lee's Summit, Missouri was designated as an Entitlement Community eligible to receive Community Development Block Grant (CDBG) funding by the Department of Housing and Urban Development (HUD); and,

WHEREAS, the City adopted the 2020-2021 Annual Action Plan on or about April 28, 2020, as required by HUD; and,

WHEREAS, on December 9, 2020, the City Council Community and Economic Development Committee held a public hearing to receive comments related to the urgent need to amend the 2020-21 Annual Action Plan to allow for HUD waivers enacted by the Coronavirus Aid, Relief, and Economic Security (CARES) Act; and,

WHEREAS, the City desires to adopt a second Substantial Amendment to the Annual Action Plan for the 2020-21 CDBG program year; and,

WHEREAS, on August 11, 2021, the City Council Community and Economic Development Committee held a public hearing to receive comments related to the request to amend the 2020-21 Annual Action Plan to allow for Lee's Summit Housing Authority to amend their scope of work and timeframe; and,

WHEREAS, the City desires to adopt a third Substantial Amendment to the Annual Action Plan for the 2020-21 CDBG program year.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City of Lee's Summit 2020-2021 Annual Action Plan be amended to eliminate the 15 percent cap on Public Services activities, and

SECTION 2. That the City of Lee's Summit 2020-2021 Annual Action Plan be amended to allow for reimbursement costs to prevent, prepare for, and respond to coronavirus,

SECTION 3. That the Mayor and/or City Manager or their designees, as appropriate, are hereby authorized and directed to take such further action, and to execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. That all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.
