

BILL NO. 21-206

AN ORDINANCE APPROVING AMENDMENT NO. 3 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2022, AS ADOPTED BY ORDINANCE NO. 9184 AND ORDINANCE NO.9187, BY AMENDING THE AUTHORIZED EXPENDITURES IN THE GENERAL FUND, THE ENTITLEMENT FUND, AND THE FLEET OPERATIONS FUND FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Ordinance No. 9184 and Ordinance No. 9187, passed by the City Council on June 16, 2020, adopted the authorized expenditures for the City of Lee's Summit; and,

WHEREAS, the staff interim budget team has determined there were some administrative errors made during budget development that need corrected; and,

WHEREAS, these corrections include an entry error in the Entitlement Fund and the submission of an outdated vehicle specification by a department as part of expansion request; and,

WHEREAS, there is also an operational need to budget the purchase of a vehicle that was previously approved by the City Council in FY21 Budget, but was unable to be completed during the prior fiscal year due to supply chain issues.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2022, of the City of Lee's Summit, Missouri, are amended in the following manner:
