Business

2021-4197 Staff Report, Fuel Sales & Fuel History

John Ohrazda, Airport Manager, recognized Joel Arrington, Assistant Airport Manager, for taking the large part of his days tracking and ordering fuel for the Airport. Nationwide there is difficulty getting fuel, a shortage of drivers and other various issues. The Airport is setting records on jet fuel, going through a tanker of fuel per week. The Airport sold 27,000 gallons of fuel for the month of July. Mr. Arrington is ordering 7-10 days in advance.

Based aircraft and an increase in turbo props and jets are one of the reasons we are seeing an increase of jet fuel sales at the Airport. Chair Townsend

asked how the Airport stays ahead of it and if there are additional needs for storage. Mr. Arrington responded this is a two-step approach. The first is the size of the fuel farm and the rate at which the City needs to order fuel. The second, Mr. Ohrazda responded, is that in the current CIP plan the City has a storage facility or fuel farm to be built sometime in the future. Currently, Mr. Ohrazda is researching the cost of putting in a saddle tank next to the existing tank in order to have the capability to have two loads of fuel. The mentioned fuel farm would be based upon land that needs to be acquired.

Mr. Arrington mentioned the Airport just received delivery on a potable water cart, a new service being offered. Fresh water can be delivered onto aircraft, which is an amenity. There is a \$75 fee for this service.

Mr. Anderson reminded the Commissioners that the Airport Master Plan and Business Plan have been adopted by City Council. The City would like to hold a celebration on Sept. 22, with an outdoor event at the Airport in the afternoon to kick off with the Mayor speaking, and members of the BOAC are invited to attend. Phase 2 of the Master Plan has been submitted to the state. A tower feasibility study, and GIS imagery for future build out, will be included in Phase 2.

This Presentation was received and filed.

Roundtable

Commissioner Mall asked if fuel sales spiked due to Oshkosh traffic. Mr. Ohrazda responded not likely - this has actually been the worst year traffic-wise for Oshkosh visitors flying through the City. This is most likely due to bad weather in the area on or about July 25, 2021. Commissioner Benson commented on seeing the increasing number of large jets utilizing the Airport. Mr. Ohrazda again noted the increase in fuel sales.

Oct. 11 is the next scheduled BOAC meeting.

Chairman Townsend would like for BOAC meetings to be held in person soon, and thanked everyone for their understanding since the County has ordered mask mandates until October.

Chairman Townsend adjourned the August 9, 2021, Zoom meeting of the Board of Aeronautic Commissioners at 7:30 p.m.
