## **BILL NO. 21-230**

AN ORDINANCE APPROVING THE DUAL AWARD OF BID NO. 2022-023, TO PURCHASE AMMUNITION ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO ON TARGET AMMUNITION, LLC AND ZOOM TECHNOLOGIES, LLC, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued Bid No. 2022-023 ("Bid") for ammunition; and,

WHEREAS, the Bid was advertised through the City's e-procurement system, Public Purchase, and sent to 26 potential bidders; and,

WHEREAS, at the close of the Bid four (4) bidders had submitted responsive and responsible bids; and,

WHEREAS, based upon the evaluation of responses and bid criteria, the City recommends awarding of the Bid to both On Target Ammunition, LLC and Zoom Technologies, LLC; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if a City contract has or is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's dual award of Bid No. 2022-023 to On Target Ammunition, LLC and Zoom Technologies, LLC for the purchase of ammunition.

SECTION 2. The agreements between the City and On Target Ammunition, LLC, attached as Exhibit A and incorporated herein by reference, and between the City and Zoom Technologies, LLC, attached as Exhibit B and incorporated herein by reference, are approved, and the City Manager is authorized to execute the same in substantially the same form as the attached on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
