AN ORDINANCE APPROVING THE AMENDED PETITION TO ADD PROPERTY TO THE SUMMIT FAIR COMMUNITY IMPROVEMENT DISTRICT AND AUTHORIZE A SALES TAX AND SPECIAL ASSESSMENTS ON SUCH ADDED PROPERTY.

WHEREAS, on January 13, 2010, pursuant to the Community Improvement District Act, Section 67.1401 *et seq.* ("Act"), an Amended Petition to Add Property to the Summit Fair Community Improvement District and Authorize a Sales Tax and Special Assessments on Such Added Property ("Petition"), signed on behalf of a property owner owning more than fifty percent by assessed value of the Property proposed to be added to the District, as described more fully in the Petition, and more than fifty percent per capita of all owners of said Property was filed with the City Clerk; and,

WHEREAS, the Petition contains all materials and information required by the Act, and has been examined by the City Clerk and found to be in substantial compliance with the requirements of the Act; and,

WHEREAS, a public hearing was held on February 4, 2010, in compliance with the Act; and,

WHEREAS, the City Council desires to adopt an ordinance approving the addition of the Property to the Summit Fair Community Improvement District.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI AS FOLLOWS:

SECTION 1. The City Council hereby finds and determines that the Amended Petition to Add Property to the Summit Fair Community Improvement District and Authorize a Sales Tax and Special Assessments on Such Added Property, a copy of which is attached hereto as **Exhibit A** and incorporated herein by this reference, is complete and proper in all respects and in compliance with the requirements of the Act, and the Petition is hereby approved.

SECTION 2. The addition of the Property to the District is hereby approved. The District, as expanded, includes the contiguous tracts of real estate as described in **Exhibit B**, and shown on a map as depicted in **Exhibit C**, both of which are incorporated herein by reference.

SECTION 3. The City Clerk is directed to report in writing the addition of the Property to the Summit Fair Community Improvement District to the Missouri Department of Economic Development.

SECTION 5. That this ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
