SUMMARY OF PROPOSED CHANGES to CHAPTER 29 (TRAFFIC)

- (1) Administrative Review. Clarified and amended various sections of the Code to better align with current practices and RSMo. model ordinances. Removed or updated regulations (e.g. honking required when passing, cyclists use of right arm for turn signaling) where law was outdated or to address design conflicts. These revisions are "clean up" unrelated to PDD's, Micro-mobility, or Neighborhood Vehicles.
- (2) Added provisions for Personal Delivery Devices (PDD). The State added law in passing Senate Bill 176 for PDD's effective 8/28/21. PDD's are cannot be defined as a vehicle or motor vehicle. PDD's are allowed on City streets and primarily operate on sidewalks, provided the PDD shall not unreasonably interfere with traffic. PDD's have certain identification requirements, braking system, etc.; however, the City cannot regulate PDD design, manufacture and maintenance, nor the types of property transported. The City may regulate operation of a PDD to ensure the welfare and safety of its residents. *RSMo. 304.900*
- No person in or upon the vehicle (e.g. remotely navigated).
- No person transportation. Only product deliveries.
- No registration required. However, device and operator identification required on the device.
- Subject to all vehicular and pedestrian traffic laws.
- Allowed upon roadways with a speed limit of 35 mph or less.
- Intended for use on sidewalks without limits on location, but speeds may not exceed 10 mph.

- (3) Added provisions for Micro-mobility Devices. Generally consistent with laws applicable to bicycles. In some instances, bicycle operation is impacted by the regulations for micro-mobility (e.g. limited to streets 35 mph or less, unless in a bike lane or paved shoulder or multi-lane corridor). Specific types of micro-mobility devices were defined, including Electric Bicycle, Electric Tricycle, and Scooter, as well as Micro-Mobility Device in general that has Electric Assist of similar design, operation and function. An Electric Bicycle may be defined as Class 1, Class 2, or Class 3, consistent with RSMo.
- No driver's license required.
- No registration required.
- Subject to all vehicular and pedestrian traffic laws when operated on streets and sidewalks, respectively.
- Restricted to roadways with a speed limit of 35 mph or less (except a Class 3 E-Bicycle; 45 mph).
- Allowed on sidewalks and trails outside the Central Business District, unless otherwise posted/noticed. Except a Class 3 E-Bike (like a Motorized Bicycle or Motorized Scooter) is not allowed on Sidewalk or Trail.

Motorized Scooter was clarified in the Code in this amendment, being the same as Motorized Bicycle that is already within Code, in consideration of the introduced Scooter, which may or may not be Electric Assist. Electric Assist Scooter is not the same as Motorized Bicycle or Motorized Scooter.



(4) Added provisions for Golf Carts and other Low Speed Vehicles, generally categorized as Neighborhood Vehicles. Neighborhood Vehicles are Vehicles, but not defined as Motor Vehicles. Definitions and laws referenced RSMo. 304.034, similar to Grain Valley Municipal Code (and others) that allow for Neighborhood Vehicle operations upon certain City streets.

- Driver's license required.
- Insurance required.
- No State registration required and no City registration required, but proof of ownership required.
- Subject to all vehicular traffic laws.
- Restricted to roadways with a speed limit of 30 mph or less.
- Not allowed on sidewalks or trails (unless specifically designed for Golf Carts; e.g. golf courses).

Micro-Mobility Devices allowed upon Trails unless otherwise posted or prohibited by Ordinance (e.g. Class 3 E-Bicycle, Motorized Bicycle). Micro-Mobility Devices prohibited upon Courts, Park Areas, Park Facilities (e.g. Skate Park), and Parking Structures where posted.

Not always a registered motor vehicle; but requires insurance and regulated like a motorcycle. (Commonly referred to as a MoPed)
