Discussion of language for eminent domain and local election priorities

Eminent Domain:

There was general discussion regarding eminent domain and how it is believed that this specific bill is focused more on broadband than farmland.

There was discussion regarding how to add this item on the priorities brochure and the language that would be best to use.

There was extensive discussion regarding how important it is to have and maintain personal relationships with the Legislators. A suggestion was made to compile a list/timeline of all events/activities that Legislators are invited to attend locally throughout the year (i.e. -events held by EJCBC, Chamber, EDC, MML and R-7, etc.). Once the list is compiled, sharing it with Mayor and Council so they are aware of opportunities and can plan to attend when available.

- local elections should stay non-partisan, and
- decisions on local taxation should stay local without special majorities.

Local Elections (or Democracy)

We Believe:

- Municipal elections should maintain their own day.
- Non-partisan local elections should stay non-partisan.
- Maintain current tax vote majorities.
