#### Call to order

  - Include shirts for volunteers. Donations can be run through a 501C3.
- -Vendors assigned to Saadia Mahmood
  - Need business license and responsible for collecting sales tax.
- -Logo/Promotions assigned to Kerrie Lindberg

Other items to be considered: Public Safety needs, Performers, Food Service permits, taxes, how to recruit volunteers, submit budget to Mayor and City Council, Port-A-Potty.



Chairperson Hickman would like to have the vendor packets out in January. She noted the city does not have this event in the budget. There was discussion about advertising on the electric billboard at  $3^{rd}$  & Ward.

City staff will forward a Special Event permit form to the Commission. Permit fee is estimated to be \$300.
