### **CALL TO ORDER**

Mayor Rhoads called the May 11, 2017, Regular Session No. 35 of the Lee's Summit City Council to order at 6:15 p.m.

### APPROVAL OF AGENDA

On motion of Councilmember Mosby, second by Councilmember Seif, the Council voted unanimously to AMEND the agenda by switching the order of the two agenda items.

### 1. PUBLIC COMMENTS:

Mr. Michael Walk, 632 NE Michael, discussed problems with the property at 636 NE Michael and his attempts to get the homeowner to maintain the property. Mayor Rhoads asked Staff to discuss this problem with Mr. Walk and help to find a solution.

Mr. Robert Dye voiced objections to Councilmember Forte. Mr. Steve Lathrop spoke in defense of Councilmember Forte.

### 2. **COUNCIL COMMENTS:**

Mayor Rhoads asked Police Chief Forbes to reach out to Grandview, following unfortunate events from last week when violence erupted at a

community-wide event. Downtown Lee's Summit Main Street will be holding the annual Downtown Days the first weekend in June and he wanted to make sure the City was prepared if something should occur.

### 3. ITEMS FOR DISCUSSION:

### A. 2017-1138 Consideration of District 4 City Councilmember filings

public and the submittal of applications, Mayor and Council notice conducted interviews to fill the vacant seat in District 4. Ten citizens from District 4 applied for consideration and were present at the meeting. Each afforded а five-minute period the candidate was in which to speak and common theme was their genuine passion for this city and for quality of life for their families and other members of the community.

Councilmembers were provided an opportunity to ask questions specific candidates. Some of the questions were how they would handle conflict tough decisions, how to effectively communicate with constituents, three main issues they feel the City is facing. One ocuniclmember asked all the candidates if they were only interested in serving this one year and no one raised a hand, indicating their interest to participate in future elections.

After all questions were asked and answered, Mayor Rhoads opened the floor for nominations. While the entire Council and the Mayor agreed that all ten candidates were excellent, Councilmember Edson nominated Mr. Fred DeMoro, Councilmember Carlyle nominated Ms. Gladys Bratton and Councilmember Binney nominated Ms. Dana Arth.

A roll call vote was held and Councilmembers voted on those who were nominated, as follows:

The vote determined Mr. Fred DeMoro, with four votes, to be the candidate who will fill the one-year vacancy. In April of 2018, both Council seats in District 4 will be available for election. Councilmember Mosby's term will expire and he will not be eligible to run due to Charter limits of serving only two consecutive terms. The other election will be for a two-year term to fill the remaining time for this seat, which will expire in 2020.

Mayor and Council congratulated Mr. DeMoro and expressed their appreciation to all the candidates who took the time and effort to participate in this process. The Mayor and Council look forward to their future involvement in the City organization.

### **B.** <u>2017-1177</u>

Consideration pursuant to Section 3.8 of the City Charter to consider initiation of City Council proceedings regarding potential violation of Section 14.1 and applicability of Section 3.7(b) of the City Charter regarding Missouri Ethics Commission filings dated April 20, 2017 that relate to Councilmember Diane Forte.

Mayor Rhoads opened discussion on the issue, as permitted by Charter, to determine if a majority of the Council wished to initiate action against Councilmember Forte.

Councilmembers spoke on both sides of the issue. Following discussion, a motion was made by Councilmember Mosby, seconded by Councilmember Edson, to proceed with a hearing adhering to Section 3.8 of the Charter in the matter for Diane Forte. A roll call vote rendered the following decision:
