Councilmember Binney advised he had attended the dedication of a new Little Free Library. The dedication was for Brian and Sandy Cox who have been very involved in the community for many years.

Councilmember Faith thanked former Councilmember Gray for attending the meeting this evening and for his previous years served as a Councilmember.

Councilmember Binney asked for staff to respond to some of the questions Mr. Keith Foster presented during Public Comments.

Mr. Mark Dunning, Assistant City Manager, advised staff is continuing to work with Mr. Foster and address his concerns. Staff has not done anything against policy and also continues to work with the developer as well. There will be a written communication and update on this forthcoming soon.

13. STAFF ROUNDTABLE:

Councilmember Binney asked for an update on the search for a Human Resources Director.

Mr. Steve Arbo, City Manager, advised the Finance and Budget Committee would have more information given to them next week. Once this information has been reviewed and more decisions have been made, staff can start the recruitment process.

Mr. Arbo stated Lee's Summit was voted the 19# Best Places To Live according to Wall Street 24/7. This is the second year in a row the City has been ranked within the top 20 from cities across the nation.

Chief Poeschl advised there would be a ceremony at 9:00 am at the Lee's Summit Fire Department promoting Benjamin Hicks to Fire Captain while he is currently serving his country in another state. The promotion will be done via satellite. Mr. Wes Blanscet, Fire Specialist, who is serving with Mr. Hicks, will be badging Mr. Hicks. Mr. Hicks' family will be present to accept his red helmet. Chief Poeschl stated this will be the first time this has been done via satellite and looks forward

to the ceremony.

Mr. Arbo advised Council there was a need to fill two positions with the Communications Center at the Fire Department. There is currently one person that is retiring and another that is on extended medical leave. He asked council for permission to fill these positions to avoid having to force current personnel to work overtime. Council could not reach a consensus to do so.
