Mr. Coy presented a handout mentioning two City of Lee's Summit Ordinances; Sec.29-233 – Drivers to sound signaling device before passing. Any operator or driver overtaking and desiring to pass a vehicle shall sound his horn before starting to pass; and, Sec.29-41 – Public Safety Advisory Board established; duties. B. The Board shall perform the following duties: 3. Review and study the City's traffic and parking ordinances and make recommendations to the City Traffic Engineer and the City Council pertaining thereto. Mr. Coy stated he stumbled across the first ordinance mentioned which seems to be more in need of a revision than the motorized bicycles. Chairman Morrow suggested discussing recodification of the City's code of ordinances at a future meeting.

On June 14th, the Hearing Board met with the owners and the reporting Animal Control Officer to allow this due process to take place. The Hearing Board upheld the Dangerous Dog Declaration.
