# A. Animal Control - Drayton Riley

Board Member Riley stated he has a copy of an e-mail referring to a recent CEDC meeting where a citizen spoke about Animal Control and Dangerous Dogs. Mark Dunning was requested to present this ordinance at an upcoming meeting of the CEDC for review. In the e-mail, there was also an inquiry as to whether the PSAB would be interested in reviewing the ordinance. Board Member Riley commented he was not opposed to looking at the ordinance; however, he was not sure about the nature of the citizen's comments.

Council Liaison DeMoro stated Mr. John Taylor is the citizen who spoke during public comments at the CEDC meeting. Mr. Taylor resides in Pryor Meadows. His concerns were based on three dogs that have been killed in his neighborhood, the lack of Animal Control personnel, and response times. Mr. Taylor asked if the leash law and dangerous dog ordinance could be reviewed.

Council Liaison DeMoro stated the tow contract was in fact peeled back to a one year contract by an amended ordinance.

Police Legal Advisor Beth Murano shared that changes made to the ordinances will not be substantial. It will be more of cleaning up the ordinances; such as, typos or number changes that have occurred after the last recodification.

Chairman Morrow stated he will contact the City Clerk to schedule a time for her to attend a future meeting to provide more information on the recodification process.
