Councilmember Faith stated that he, Mayor Rhoads and Mayor Pro Tem Binney all attended the services for fallen Officer Thomas Orr. He complimented Chief Forbes for his address at the services and thanked the community for their support of this officer and all officers in the city.

Councilmember Carlyle asked what would happen with the tower at Clifford Road now that the applicant had withdrawn. Mr. Ryan Elam stated the city will open a case as they are now in violation of the Code and would hold the applicant to the timeline they had previously provided. They still had one provider still located on the pole, they will have them moved within three months and the tower should be down within 6 months.

11. STAFF ROUNDTABLE:

Mr. George Binger provided Council and update on Scherer Road. A section of the road had recently collapsed due to water damage. The repairs will be complete and staff hopes to have the road re-opened tomorrow, Friday, August 25th by 5:00 p.m.

Chief Forbes thanked the Mayor and Council for their support of Officer Orr and the police department. He also thanked the community for their continued support. He said Mr. Orr's family definitely felt the appreciation of thier son through the community support.
