B. 2018-2455 Discussion of the Use Tax

Mayor Baird advised he did not feel the Use Tax was ready to be put on a ballot in April as originally planned. He stated he recently reviewed his online purchases and the amount of taxes the City was losing on just in what he had purchased for himself and his family.

It is estimated the City is losing approximately \$1.3M in taxes without implementing the Use Tax. The State of Missouri is already collecting the use tax. This would also assure an equally competitive environment for local businesses. It would create diversity to and modernize the revenue stream.

In order to place this on the April 2, 2019 ballot, the Council would need to take action by January 15th. Since there is a lot of education involved the Council will look at this tax with the Strategic Plan. They will also review the Debt Capacity for 2019 before making a decision on the placement of the use tax on the ballot.
