Councilmember Forte noted the city had been facing some negativity due to recent activity on the School Board. She wanted to point out that a citizen recently created a Facebook page in light of this negativity called Good New LSR7. The page had 1700 followers within a half of a day with lots of great comments about the schools from parents, teachers, and citizens. She thought this was more what Lee's Summit was about.

Mr. Steve Arbo, City Manager, also thanked the voters and stated he was very pleased with the election. It had one of the highest percentages of acceptance of bond issues among the voters. He reminded everyone that even though these measures passed, that does not mean that all will be implemented immediately.
