6. OLD BUSINESS:

There being no items to discuss, the Board moved onto New Business.

7. NEW BUSINESS:

- A. Board member Fred Pickard stated that he is on three (3) committees and would like to relinquish the Traffic Safety committee. Board member Jennifer Nussbeck volunteered to work on that committee. Pickard was relieved of the Traffic Safety committee.

8. DEPARTMENT REPORTS:

A. Fire Department – Fire Chief Mike Snider – Asst. Chief Jim Eden

- 1) An Incident Report for the month of August 2020 was presented and discussed.
- 2) An update was provided on other various Fire Department issues.
- 3) COVID 19 has impacted EMS and Fire calls and personnel, returning to normal. In March 2020, full activation of State of Emergency – public health – Had to wait for rules and processes from Jackson County. Dan Manley focused on response regional and statewide PPE.
- 4) Station 3 is nearing final stages. Stations 4 & 5 need to be replaced and they are looking into land acquisition.
- 5) Fire went to the new radio system in August. Some issues are being worked out.
- 6) A new Pumper 5 has arrived. The old Pumper 5 was involved in an accident last winter and is being repaired. Five (5) new ambulances has arrived, one being in an accident early on and is being repaired.
- 7) Three (3) were promoted to Captain and 6 paramedics were hired.
- 8) Set for re-accreditation in December 2021. Casey Smith is next manager of accreditation.
- 9) Awards ceremony was virtual.
- 10) This year has been challenging, have to have different thinking processes.

B. Police Department – Police Chief Travis Forbes

- 1) An Incident Report for the month of January was presented and discussed.
- 2) An update was provided on other various Police Department issues.
- 3) Due to Covid 19 – the statistics are trending downward.
- 4) Happy with new radio system. There are two missing pieces that are being worked on – speaking to other agencies and GPS on mobile. Great reviews.
- 5) Everyone has been equipped with body cameras and policies are being worked out.
- 6) In car video system is still being worked on.
- 7) The Records Management System is upgraded and training is being finished.
- 8) Police building project – architect and builder are into final plans.
- 9) Two promotions to Sergeant, Nick Rippey and Matt Miller. D.A.R.E. Officer Chris Colon retired.
- 10) Covid 19 response – dealt with side issues but was never short of PPE.
- 11) Many special events have been cancelled. June was the heaviest month for civil unrest, we had peaceful protests. Information was provided on Facebook.
- 12) Police department was just re-accredited. We have to do this yearly.
- 13) We can't enforce mask orders that were put in place by the County Executive orders.

C, Public Works –

An update was not provided due to the absence of Public Works representation.

9. ROUNDTABLE:

Various items were discussed. Chairman Trammell requested that officer involved shooting and review of the Use of Force Standard policy and procedures be discussed. Jim Pryde is on this committee. This is to be placed on the October 19th Agenda.

Chairman Trammell also stated they would start with a five (5) to 10 minute presentation of body cameras (Use of Force) in October and to be placed on the agenda.

Board member Pickard stated to Chief Eden that there is a problem with Google fiber lines on the ground. Chief Eden stated he would look into it

A Zoom meeting will most likely occur in October.

10. ADJOURNMENT:

Board members Ken Davis made a motion to adjourn with Board member Fred Pickard seconding the motion. Motion carried. Meeting adjourned at 4:05 p.m.
