#### 3. Approval of Agenda

Councilmember Shields made a motion to approve the March 10, 2021 Community and Economic Development Committee agenda as presented, seconded by Mayor Pro Tem Lopez.

#### 5. Business

**A. [2021-3986](#) Approval of the February 10, 2021 Community and Economic Development Action Letter.**

Vice Chair DeMoro made a motion to approve the February 10, 2021 Community and Economic Development Committee action letter, seconded by Councilmember Shields.

**The motion passed unanimously by voice vote.**

**B. [2021-3972](#) Public Hearing: Community Development Block Grant Annual Action Plan for Program Year 2021-22**

Sarah Tilbury, CDBG Administer, presented an overview of the 2021-22 CDBG Annual Action Plan process and timeline. The HUD CDBG Grant amount for Lee's Summit is \$350,684.00, a decrease of \$22,000 from last year.

However, there is additional unspent prior year funds of \$97,555.40 to be used for reallocation bringing the total CDBG funds available for 2021-22 to \$448,239.40.

A representative from each of the following organizations presented information about their funding requests and then Amy Koeneman, Administration Manager, Development Services, presented staff recommendations as follows:

Planning and Administration (20% Cap) \$70,136.80 available for allocation:

- City of Lee's Summit (\$70,136.80)

Public Services (15% Cap) \$52,602.60.60 available for allocation:

- Coldwater of Lee's Summit (\$5,372.06)
- Hope House (\$10,072.62)
- Lee's Summit Social Services (\$16,787.71)
- Hillcrest (\$16,787.71)
- ReDiscover (\$3,582.50)

Other (no Cap) Remaining Amount + Prior Year Funds for Reallocation (\$325,000)

- Lee's Summit Housing Authority (\$200,000.00)
- Truman Heritage for Habitat (\$125,000.00)

Ms. Koeneman explained because the total 2021-22 CDBG funding amount was reduced, all Public Services organizations were asked to reduce their requested amounts by 33% and all

agreed. Therefore each applicant will receive approximately 67% of their requested funding.

Ms. Koeneman further stated since the prior year Funds Available for Reallocation had been identified for the Minor Home Repair Program and must be spent before HUD retracts the unspent funding, staff suggested applying all those funds to Truman Heritage for Habitat.

Discussion followed.

Vice Chair DeMoro made a motion to recommend for City Council approval the Community Development Block Grant Annual Action Plan for Program Year 2021-22, seconded by Mayor Pro Tem Lopez.

**The motion passed unanimously by voice vote.**
