Dish Wireless equipment on the Longview Water Tower. He began the discussion by presenting the HPC with a brief explanation of what the Sec. 106 of the National Historic Preservation Act was and how it pertains to the HPC's mission. After a thorough and robust discussion, the Commission vote unanimously to request the applicant mitigate the negative visual impacts of adding additional equipment to the historic tower by installing a sign near the tower to interpret the history of the tower and the Longview Farm.
