Commissioner Mahmood stated she has a friend that is on the Diversity and Inclusion Commission for Parkville and thought it would be beneficial to reach out to them to network as well.

Commissioner Holland said he is excited about the work they are doing as it becomes tangible. He is encouraged and motivated to keep moving forward.

Mr. Arbo said his employment with the City for over 20 years is due to the great employee's, elected officials and citizen groups that continue to move the ball forward. He expressed his appreciation to the group.
