1. Call to Order

Chairperson Forte called the January 12, 2022 Community and Economic Development Committee meeting to order at 5:04 p.m.

3. Approval of Agenda

Vice Chair DeMoro made a motion to approve the January 12, 2022 Community and Economic Development Committee agenda, seconded by Councilmember Felker.

The motion passed unanimously by roll call vote.

A. 2021-4592 Approval of the December 8, 2021 Community and Economic Development Action Letter.

Councilmember Felker made a motion to approve the December 8, 2021 Community and Economic Development Committee Action Letter, seconded by Vice Chair DeMoro.

The motion passed unanimously by roll call vote.

3. 2022-4628 Review and Discussion of Economic Development Incentive Policy and incentives related to multi-family projects

Mark Dunning, Assistant City Manager, presented the history of the City's Economic Development Incentive policy for Multi-family project requests and reviewed the process flow chart used to consider incentive applications.

During discussion the committee shared concerns regarding fixed PILOTS and sales tax exemption requests. Staff stated they would bring forward additional policy ideas based on discussion.

C. RES. NO. 22-03

A Resolution establishing a Proactive Code Enforcement Policy to guide the enforcement of the adopted Property Maintenance Code, the Unified Development Ordinance and the Business License Code in the City of Lee's Summit, Missouri.

Dan Harper, Assistant Director Development Services, reviewed the Proactive Code Enforcement Policy and implementation plan. This information had previously been presented at the November 10, 2021 Community and Economic Development Committee meeting. He also provided a proposed resolution describing the program and goals of the plan.

Councilmember Felker made a motion to recommend that the City Council approve the resolution to implement the proactive code enforcement policy, seconded by Chair DeMoro.

The motion passed unanimously by roll call vote.

6. Roundtable

Mark Dunning, Assistant City Manger, stated staff will make a full presentation to the City Council when the Pro-Active Code Enforcement Resolution is presented, as suggested by the Community and Economic Development Committee.
