Begin identifying what information they want to garner from these groups.

- -Experience Viewpoints
- -What do they see as needs, gaps, what is working well, what might be done differently
- -Have they surveyed their own members and would they be willing to share that information
- -What are they trying to accomplish
- -Who are their members

Common set of questions, a presentation and a common assessment tool.

- -Would a survey for the Lee's Summit Chamber be answered by the President or sent to all 300+ businesses? The data could get very large and there would need to be a plan to handle all of it.
- -Could hone in on minority groups
- -See what the assessment person the Commission is going to be hiring is assessing so there isn't overlap.
- -Two stage, start with an introductory conversation, second stage gathering data.

Developing a set of guestions and discussion items.

Identify Groups to interview. Next meeting solidify how to do it.

Develop assessment tool/survey – draft for discussion at October meeting

Will the interviews be recorded? Will there be a summary report to share with the public? Will the groups be identified but the comments summarized? It was decided by consensus to summarize the groups interviewed and summarize the comments but not to link the comments to any certain group.
