1. First paragraph first sentence only -suggested change:

2. Under Revenue - Third bullet suggested change:  
"Support Tax Legislation that protects Municipal Revenue"

The Consensus of the Committee agreed to make the suggested changes as discussed and have staff send a Resolution to the full Council for the December 21, 2021 Council meeting.
