Consensus of the Committee was to invite Lobbyist Jim Durham to present an update to the City Council on Tuesday, July 19, 2022.

- C. [2022-4975](#) Review Bills approved by the Legislature

Daniel White, Chief Counsel of Management and Operations filled in for City Attorney Brian Head at the meeting. Dan gave a brief update on legislative items that once signed by the Governor could impact the City of Lee's Summit.

He initiated the discussion by mentioning that the State Budget has included the City of Lee's Summit in receiving \$10.5 M in matching funds for necessary sewer upgrades as part of the PRI properties. Should the budget pass, the Committee would like to acknowledge those that assisted in getting the funds for the City.

Staff was asked to follow-up with our lobbyist to gather names of all that assisted and once the budget has passed, the Committee would like to find a way to recognize and thank those individuals.

Dan continued going through a list of bills that could impact the City relative to 1) Economic Development, 2) Local Regulations, 3) Taxing Authority, 4) Sunshine Law, 5) City Employees, and, 6) Elections.
