**A.** 2022-5198 Approval of the September 12, 2022 Legislative Intergovernmental Relations Committee Action Letter.

B. 2022-5124 Continued Discussion of 2023 Legislative Priorities

Discussion revolved around:

1. HB 1662: Changes the laws regarding restrictive covenants by expanding the definition of prohibited covenants and establishes a procedure to remove prohibited covenants from deeds. This bill would negatively impact the City of Lee's Summit's ability to regulate home based businesses.

After brief discussion, Consensus of the Committee was to push back on the Bill and request more clarity of impact to municipal authority.

2. <u>The Legislative Priorities Rack Card</u>: The Committee discussed the previous Legislative priorities rack card and made some minor modifications to some of the sections as follows:

Transportation:

No changes made.

Revenue:

Discussion points relative to:

- a. local sales tax caps.
- b. Fair tax coming back.
- c. General sales tax (capped at 2% and we are close to the cap).
- d. Public Safety sales tax

Consensus of Committee is to follow Staff's lead and seek authorization for a specific public safety sales tax.

Add to the first bullet point: Land Use Decisions "including Home Based Businesses".

## **Economic Development:**

### **No Changes Made**

Discussion:

CIDs and TDDs: Amend the CID ACT to allow improvements to the outside of the CID boundaries (i.e. relative to storm water, etc.).

Regarding TDD's: to be able to expand the size of the districts. Changing unanimous agreement of property owners to majority. After discussion, Consensus of the Committee would be instead of changing to majority, changing it to 75% as a middle ground.

Staff will bring back the updated document to the next meeting.

## 6. Roundtable

Chairperson Shields inquired regarding the status of inviting the Legislators who assisted with funding for the North PRI property improvements to a future City Council meeting. Mr. Head is working with Mayor Baird and City Manager Mark Dunning to find a date on the calendar to have the Legislators recognized at a Council meeting before the end of the year.

Mayor asked staff to start coming up with a list to present to Council with regards for requests for "ARPA" funds. He believes the State has more money and we need to have specific needs in mind when meeting with our Legislators.
