E. 2022-5027 Presentation: Unified Development Ordinance (UDO) Amendment - Application #PL2022-253 - a proposed text amendment to the regulations for short-term rentals (UDO Section 6.505); Jennifer Krause, applicant.

Jennifer Krause, 111 SE 3rd Court, Lee's Summit, Missouri, presented information in support of this UDO change. She stated If this is regulated correctly this could be a benefit to the community. She is requesting to expand the area for short-term rentals to include the area East 291 Hwy. at Langsford Road south to 350 Hwy. and east to Todd George Parkway and also increase the rooms to be rented from two bedrooms to three bedrooms.

Hector Soto, Jr., Senior Planter, reviewed the current UDO regulations and explained why staff does not recommend the proposed changes requested for the following reasons:

1. The new area is outside the walking distance of the Old Town Master Development Area - not pedestrian friendly

2. The room limit was devised to limit the impact of guests on surrounding neighbors (parking, traffic, neighborhood complaints)

Discussion ensued.
