An Ordinance amending the Economic Development Incentive Policy for the City of Lee's Summit, Missouri

Key Issues:

The Community and Economic Development Committee held discussions regarding the Economic Development Incentive Policy at the following meetings:

The approval of the attached ordinance will incorporate the amendments discussed at those meetings into the Policy.

 - Expanded criteria related to Industrial Projects
 - Updates to the application and review process

Background:

In February 2015, the City Council adopted Ordinance 7588 creating the Economic Development Incentive Policy

In October 2015, the City Council amended the Policy by adoption of Ordinance 7725

In January 2018, the City Council amended the Policy by adoption of Ordinance 8322

In January 2020, the City Council amended the Policy by adoption of Ordinance 8801(a)

In April 2022, the City Council amended the Policy by adoption of Ordinance 9804

Staff recommends approval of the ordinance.

At the June 14, 2023 Community and Economic Development Committee meeting a motion was made by Councilmember Felker, seconded by Councilmember Hodges to recommend for City Council review and approval of the revised Economic Development Incentive Policy. The motion carried by a vote of 4-0 and was recommend for approval.
