# Issue/Request:

AN ORDINANCE APPROVING THE EXECUTION OF THE FUNDING/APPROVAL AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE 2016-2017 CDBG PROGRAM YEAR.

# Key Issues:

- -In August of 1994, the City of Lee's Summit, Missouri ("City") was designated as an Entitlement Community eligible to receive Community Development Block Grant (CDBG) funding by the U.S. Department of Housing and Urban Development (HUD).
- -The City Council has previously approved, passed and adopted via ordinance the City's 2016-2017 Annual Action Plan.
- -HUD has approved the City's Action Plan for the 2016-2017 Fiscal Year (a/k/a 2016-2017 Annual Action Plan).

HUD has allocated the amount of \$369,299.00 to the City to carry out its and its sub-recipients' CDBG programs for the 2016-2017 program year.

The City desires to enter into a Funding Approval/Agreement with HUD in order to receive the allocated CDBG funding.
