Public Hearing: Application #PL2022-005 - Special Use Permit renewal for assisted living care facility - Wilshire at Lakewood, 600 NE Meadowview Drive; Wilshire Properties, LLC, applicant.

**Issue/Request:**

The applicant seeks renewal of a special use permit for a period of perpetuity to allow the continuation of the use of an assisted living facility/convalescent, nursing and/or retirement home, on the subject property. The property is located at 600 NE Meadowview Dr. and was built around 1997.

The requested perpetual time period isn't a time period staff can support or recommends for this use at this property; it is not the City's practice to grant special use permits in perpetuity. Staff recommends a period of 25 years dating back to the expiration date of February 18, 2017, to allow for the new expiration date of 2042.
