Issue/Request:

AN ORDINANCE APPROVING, ADOPTING AND APPROPRIATING THE BUDGET OF THE CITY OF LEE'S SUMMIT, MISSOURI, FOR THE FISCAL YEAR ENDING JUNE 30, 2018.

Key Issues:

The City Manager's Budget proposes a total appropriation of \$217,538,780 for all funds for the fiscal year beginning July 1, 2018 (FY2018). The total includes the expenditure budgets within the following funds;

GENERAL FUND	\$67,190,459
SPECIAL REVENUE FUNDS	\$13,366,470
DEBT SERVICE FUNDS	\$11,244,005
CAPITAL PROJECT FUNDS	\$56,091,029
ENTERPRISE FUNDS	\$55,986,791
INTERNAL SERVICE FUNDS	\$13,660,025
